Sir / Madam,

This has reference to the grievance of J & K students under Prime Minister Scholarship Scheme on the subject noted above being forwarded by AICTE (copy enclosed).

It is requested to kindly admit students of Jammu & Kashmir nominated by AICTE as this is under Prime Minister Scholarship Scheme (PMSSS) implemented by Ministry of Human Resource Development (MHRD), Delhi. It is clarified that Kashmiri students allotted by AICTE are eligible for Scholarship i.e. their tuition and hostel fees shall be released by Ministry of HRD. Further, it is also informed that the admissions are being monitored by Prime Minister Office. In this reference Indian Nursing Council has already issued letter no. 22-10/PMSSS-J&K/2021-INC dated 21.10.2021. Copy of the letter enclosed herewith.

With reference to Indian Nursing Council circular no. 22-10/NEET/2019-INC dated 11.08.2021 (copy enclosed), the admission to B.Sc.(N) program on the basis of NEET 2021 is not mandatory / compulsory. Based on the above NEET may be exempted for **Kashmiri students and they may be allowed to be admitted** in already allotted institution under Supernumerary quota for 2021-22 academic year.
